The Northeast Division annual convention is February 21st to 22nd in Scranton, PA, registration opens January 2nd.

The 2025 annual waivers are not available on-line yet, the website says they should be available by the 16th of December.

Region has received paper work for re-certification for next year, Charlie will be working on getting it completed and sent in.

Going forward the region is going to charge \$20 for weekend memberships for all programs. SCCA charges us \$15.00 for each membership we sell.

MotorsportsReg.com has been sold to an equity firm Parella Motorsports Holdings (PMH). PMH owns seven major road racing series and hosts 24 race weekends across the United States under the SpeedTour banner. Hosting more than 5,500 racing entrants during the 2023 season, PMH also holds the long-term commercial rights to SCCA Pro Racing, allowing it to sanction events for race groups like The Trans Am Series presented by Pirelli, Formula Regional Americas Championship, Formula 4 United States Championship, Formula Race Promotions and Formula 2000.
